**TERMS AND CONDITIONS for USE OF PUBLIC INTERNET STATION  
BY INDIVIDUALS 15 AND UNDER**

The Library provides public access to the Internet that is unfiltered and free of charge to permit:

- a) access to information and resources for individual enrichment, self-education, culture and recreation, and
- b) enhanced local and global communications.

The Library acknowledges that:

- a) information may be inaccurate, out-of-date or unavailable at times and therefore users are expected to evaluate the validity of all information accessed on the Internet, and
- b) some information or images may be controversial, offensive or inappropriate for children and therefore parents/legal guardians are expected to provide guidance to their children in the use of the Internet. Any restriction of a child's access to the Internet based on content viewed is the responsibility of the parent/legal guardian.

All individuals using the Internet resources at the Selwyn Public Library must agree to abide by the rules and acceptable use policy adopted by the Selwyn Public Library Board. Failure to do so will result in the removal of an individual's right to use the Internet on the public access computer at the library.

### Rules of Operation for Library Internet Computers

- a. Users may not interfere with the quiet enjoyment of the library by the general public, through disruptive behavior or the display of disturbing information and images.
- b. Users shall not access, display, download, upload, print, forward or e-mail pornographic, obscene, or criminal material (as defined by the Criminal Code of Canada) or material inciting hatred or sedition.
- c. Children 17 and under must have a signed permission form from their parents/guardians on file; or a parent/guardian must be present in the library to supervise.
- d. Users must limit their use of the workstation to 30 minutes if people are waiting. No more than two 30-minute periods are permitted in a day.
- e. A maximum of one person may work at a workstation at one time. Exceptions may be made for the purposes of homework and research projects.
- f. Users must sign-in or obtain a slip prior to using computer.
- g. Users must pay for all printing. Cost 20 cents per page.
- h. Users may not access other areas of the computer, run personal software or compromise system security.
